

## **Terms of Service**

---

### **ACCEPTANCE OF TERMS**

WORLD FILM FEDERATION ("WFF") welcomes you. WORLD FILM FEDERATION provides the Services (defined below) to you subject to the following Terms of Service ("TOS"), which may be updated by us from time to time without notice to you. By accessing and using the FEDERATION Services, you accept and agree to be bound by the terms and provision of the TOS. In addition, when using particular FEDERATION owned or operated services, you and THE FEDERATION shall be subject to any posted guidelines or rules applicable to such services, which may be posted and modified from time to time. All such guidelines or rules (including but not limited to our Spam Policy) are hereby incorporated by reference into the TOS. FEDERATION may also offer other services that are governed by different Terms of Service. In such cases the other terms of service will be posted on the relevant service to which they apply.

### **DESCRIPTION OF FEDERATION SERVICES**

WFF provides users with access to a rich collection of resources, including without limitation various communications tools, forums, shopping services, search services, personalized content and branded programming through its network of properties which may be accessed through any various medium or device now known or hereafter developed (the "WFF Services"). You also understand and agree that the WFF Services may include advertisements and that these advertisements are necessary for WFF to provide the WFF Services. You also understand and agree that the WFF Services may include certain communications from WFF, such as service announcements, administrative messages and the WFF Newsletter, and that these communications are considered part of WFF membership and you will not be able to opt out of receiving them. Unless explicitly stated otherwise, any new features that augments or enhances the current WFF Services, including the release of new WFF properties, shall be subject to the TOS. You understand and agree that the WFF Services is provided "AS-IS" and that WFF assumes no responsibility for the timeliness, deletion, mis-delivery or failure to store any user communications or personalization settings. You are responsible for obtaining access to the WFF Services, and that access may involve third-party fees (such as Internet service provider or airtime charges). You are responsible for those fees, including those fees associated with the display or delivery of advertisements. In addition, you must provide and are responsible for all equipment necessary to access the WFF Services. You understand that the technical processing and transmission of the WFF Services, including your Content, may involve (a) transmissions over various networks; and (b) changes to conform and adapt to technical requirements of connecting networks or devices. Please be aware that WFF has created certain areas on the WFF Services that contain adult or mature content. You must be at least 18 years of age to access and view such areas.

### **YOUR REGISTRATION OBLIGATIONS**

In consideration of your use of the WFF Services, you represent that you are of legal age to form a binding contract and are not a person barred from receiving the WFF Services under the laws of the United States or other applicable jurisdiction. You also agree to: (a) provide true, accurate, current and complete information about yourself as prompted by the WFF Service's registration form (the "Registration Data") and (b) maintain and promptly update the Registration Data to keep it true, accurate, current and complete. If you provide any information that is untrue, inaccurate, not current or incomplete, or WFF has reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, WFF has the right to suspend or terminate your account and refuse any and all current or future use of the WFF Services (or any portion thereof). You must be aged 13 or over to use the Services.

### **WFF PRIVACY POLICY**

Registration Data and certain other information about you are subject to our applicable privacy policy. You understand that through your use of the WFF Services you consent to the collection and use (as set forth in the applicable privacy policy) of this information, including the transfer of this information to the United States and/or other countries for storage, processing and use by WFF and its affiliates.

## **MEMBER ACCOUNT, PASSWORD AND SECURITY**

You will receive a password and account designation upon completing the WFF Service's registration process. You are responsible for maintaining the confidentiality of the password and account and are fully responsible for all activities that occur under your password or account. You agree to (a) immediately notify WFF of any unauthorized use of your password or account or any other breach of security, and (b) ensure that you exit from your account at the end of each session. WFF cannot and will not be liable for any loss or damage arising from your failure to comply with this Section.

## **MEMBER CONDUCT**

You understand that all information, data, text, software, music, sound, photographs, graphics, video, messages, tags, or other materials ("Content"), whether publicly posted or privately transmitted, are the sole responsibility of the person from whom such Content originated. This means that you, and not WFF, are entirely responsible for all Content that you upload, post, email, transmit or otherwise make available via the WFF Services. WFF does not control the Content posted via the WFF Services and, as such, does not guarantee the accuracy, integrity or quality of such Content. You understand that by using the WFF Services, you may be exposed to Content that is offensive, indecent or objectionable. Under no circumstances will WFF be liable in any way for any Content, including, but not limited to, any errors or omissions in any Content, or any loss or damage of any kind incurred as a result of the use of any Content posted, emailed, transmitted or otherwise made available via the WFF Services. You agree to not use the WFF Services to:

1. upload, post, email, transmit, or otherwise make available any Content that is unlawful, harmful, threatening, abusive, harassing, tortuous, defamatory, vulgar, obscene, libelous, invasive of another's privacy, hateful, or racially, ethnically, or otherwise objectionable;
2. harm minors in any way;
3. impersonate any person or entity, including, but not limited to, a WFF official, forum leader, guide or host, or falsely state or otherwise misrepresent your affiliation with a person or entity;
4. forge headers or otherwise manipulate identifiers in order to disguise the origin of any Content transmitted through the WFF Service;
5. upload, post, email, transmit, or otherwise make available any Content that you do not have a right to make available under any law or under contractual or fiduciary relationships (such as inside information, proprietary and confidential information learned or disclosed as part of employment relationships or under nondisclosure agreements);
6. upload, post, email, transmit or otherwise make available any Content that infringes any patent, trademark, trade secret, copyright or other proprietary rights ("Rights") of any party;

9. disrupt the normal flow of dialogue, cause a screen to "scroll" faster than other users of the WFF Services are able to type, or otherwise act in a manner that negatively affects other users' ability to engage in real time exchanges;
10. interfere with or disrupt the WFF Services or servers or networks connected to the WFF Services, or disobey any requirements, procedures, policies or regulations of networks connected to the WFF Services, including using any device, software or routine to bypass our robot exclusion headers;
11. intentionally or unintentionally violate any applicable local, state, national or international law, including, but not limited to, regulations promulgated by the U.S. Securities and Exchange Commission, any rules of any national or other securities exchange, including, without limitation, the New York Stock Exchange, the American Stock Exchange, or the NASDAQ, and any regulations having the force of law;

12. provide material support or resources (or to conceal or disguise the nature, location, source, or ownership of material support or resources) to any organization(s) designated by the United States government as a foreign terrorist organization pursuant to section 219 of the Immigration and Nationality Act;
13. "stalk" or otherwise harass another; and/or
14. collect or store personal data about other users in connection with the prohibited conduct and activities set forth in paragraphs 6.1 through 6.13 above.

You acknowledge that WFF may or may not pre-screen Content, but that WFF and its designees shall have the right (but not the obligation) in their sole discretion to pre-screen, refuse, or remove any Content that is available via the WFF Services. Without limiting the foregoing, WFF and its designees shall have the right to remove any Content that violates the TOS or is otherwise objectionable. You agree that you must evaluate, and bear all risks associated with, the use of any Content, including any reliance on the accuracy, completeness, or usefulness of such Content. In this regard, you acknowledge that you may not rely on any Content created by WFF or submitted to WFF, including without limitation information in WFF Message Boards and in all other parts of the WFF Services.

You acknowledge, consent and agree that WFF may access, preserve and disclose your account information and Content if required to do so by law or in a good faith belief that such access preservation or disclosure is reasonably necessary to: (i) comply with legal process; (ii) enforce the TOS; (iii) respond to claims that any Content violates the rights of third parties; (iv) respond to your requests for customer service; or (v) protect the rights, property or personal safety of WFF, its users and the public.

You understand that the WFF Services and software embodied within the WFF Services may include security components that permit digital materials to be protected, and that use of these materials is subject to usage rules set by WFF and/or content providers who provide content to the WFF Services. You may not attempt to override or circumvent any of the usage rules embedded into the WFF Services. Any unauthorized reproduction, publication, further distribution or public exhibition of the materials provided on the WFF Services, in whole or in part, is strictly prohibited.

#### **INTERSTATE NATURE OF COMMUNICATIONS ON WFF NETWORK**

When you register with WFF, you acknowledge that in using the WFF Services to send electronic communications (including but not limited to email, search queries, sending messages to WFF Chat or WFF Groups, uploading photos and files, and other Internet activities), you will be causing communications to be sent through WFF's computer networks, portions of which are located in Texas and other locations in the United States and portions of which are located abroad. As a result, and also as a result of WFF's network architecture and business practices and the nature of electronic communications, even communications that seem to be intrastate in nature can result in the transmission of interstate communications regardless of where you are physically located at the time of transmission. Accordingly, by agreeing to this TOS, you acknowledge that use of the service results in interstate data transmissions.

#### **SPECIAL ADMONITIONS FOR INTERNATIONAL USE AND EXPORT AND IMPORT COMPLIANCE**

Recognizing the global nature of the Internet, you agree to comply with all local rules regarding online conduct and acceptable Content. Use of the WFF Services and transfer, posting and uploading of software, technology, and other technical data via the WFF Services may be subject to the export and import laws of the United States and other countries. WFF does not claim ownership of Content you submit or make available for inclusion on the WFF Services. However, with respect to Content you submit or make available for inclusion on publicly accessible areas of the WFF Services, you grant WFF the following worldwide, royalty-free and non-exclusive license(s), as applicable:

- With respect to Content you submit or make available for inclusion on publicly accessible areas of WFF Groups, the license to use, distribute, reproduce, modify, adapt, publicly perform and publicly display such Content on the WFF Services solely for the purposes of providing and promoting the specific WFF Group to which such Content was submitted or made available. This license exists only for as long as you elect to continue to include such Content on the WFF Services and will terminate at the time you remove or WFF removes such Content from the WFF Services.
- With respect to photos, graphics, audio or video you submit or make available for inclusion on publicly accessible areas of the WFF Services the license to use, distribute, reproduce, modify, adapt, publicly perform and publicly display such Content on the WFF Services solely for the purpose for which such Content was submitted or made available. This license exists only for as long as you elect to continue to include such Content on the WFF Services and will terminate at the time you remove or WFF removes such Content from the WFF Services.

By submitting ideas, suggestions, documents, and/or proposals ("Contributions") to WFF through its suggestion or feedback webpages, you acknowledge and agree that: (a) your Contributions do not contain confidential or proprietary information; (b) WFF is not under any obligation of confidentiality, express or implied, with respect to the Contributions; (c) WFF shall be entitled to use or disclose (or choose not to use or disclose) such Contributions for any purpose, in any way, in any media worldwide; (d) WFF may have something similar to the Contributions already under consideration or in development; (e) your Contributions automatically become the property of WFF without any obligation of WFF to you; and (f) you are not entitled to any compensation or reimbursement of any kind from WFF under any circumstances.

#### **INDEMNITY**

You agree to indemnify and hold WFF and its subsidiaries, affiliates, officers, agents, employees, partners and licensors harmless from any claim or demand, including reasonable attorneys' fees, made by any third party due to or arising out of Content you submit, post, transmit, modify or otherwise make available through the WFF Services, your use of the WFF Services, your connection to the WFF Services, your violation of the TOS, or your violation of any rights of another.

## **NO COMMERCIAL REUSE OF WFF SERVICES**

You agree not to reproduce, duplicate, copy, sell, trade, resell or exploit for any commercial purposes, any portion or use of, or access to, the WFF Services (including Content, advertisements, Software and your WFF ID).

## **GENERAL PRACTICES REGARDING USE AND STORAGE**

You acknowledge that WFF may establish general practices and limits concerning use of the WFF Services, including without limitation the maximum number of days that email messages, message board postings or other uploaded Content will be retained by the WFF Services, the maximum number of email messages that may be sent from or received by an account on the WFF Services, the maximum size of any email message that may be sent from or received by an account on the WFF Services, the maximum disk space that will be allotted on WFF's servers on your behalf, and the maximum number of times (and the maximum duration for which) you may access the WFF Services in a given period of time. You agree that WFF has no responsibility or liability for the deletion or failure to store any messages and other communications or other Content maintained or transmitted by the WFF Services. You acknowledge that WFF reserves the right to log off accounts that are inactive for an extended period of time. You further acknowledge that WFF reserves the right to modify these general practices and limits from time to time. ## **MODIFICATIONS TO WFF SERVICES**

WFF reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, the WFF Services (or any part thereof) with or without notice. You agree that WFF shall not be liable to you or to any third party for any modification, suspension or discontinuance of the WFF Services (or any part thereof).

## **TERMINATION**

You may terminate your WFF account, any associated email address and access to the WFF Services by submitting such termination request to WFF. You agree that WFF may, without prior notice, immediately terminate, limit your access to or suspend your WFF account, any associated email address, and access to the WFF Services. Cause for such termination, limitation of access or suspension shall include, but not be limited to,

- (a) breaches or violations of the TOS or other incorporated agreements or guidelines,
- (b) requests by law enforcement or other government agencies,
- (c) discontinuance or material modification to the WFF Services (or any part thereof),
- (d) unexpected technical or security issues or problems,
- (e) extended periods of inactivity,
- (f) engagement by you in fraudulent or illegal activities, and/or
- (g) nonpayment of any fees owed by you in connection with the WFF Services.

Further, you agree that all terminations, limitations of access and suspensions for cause shall be made in WFF's sole discretion and that WFF shall not be liable to you or any third party for any termination of your account, any associated email address, or access to the WFF Services. Termination of your WFF account includes any or all of the following:

- (a) Removal of access to all or part of the offerings within the WFF Services,
- (b) Deletion of your password and all related information, files and content associated with or inside your account (or any part thereof), and
- (c) Barring of further use of all or part of the WFF Services.

Except as expressly permitted by applicable law or as authorized by WFF or the applicable licensor (such as an advertiser), you agree not to modify, rent, lease, loan, sell, distribute, transmit, broadcast, publicly perform or create derivative works based on the WFF Services, such Content or the Software, in whole or in part. WFF grants you a personal, non-transferable and non-exclusive right and license to use the object code of its Software on a single computer; provided that you do not (and do not allow any third party to) copy, modify, create a derivative work from, reverse engineer, reverse assemble or otherwise attempt to discover any source code, sell, assign, sublicense, grant a security interest in or otherwise transfer any right in the Software.
